

## Consult and Office Visit/Telehealth Price Quote

Listed below are the specific billing codes and associated fees for office consults, new patient visits and clinic follow-up visits. While we cannot guarantee the exact dollar amount of your procedure, we hope this tool will serve as a guideline when contacting your insurance company to determine your benefits.

We have included the CPT codes associated with the various procedures as a reference. Insurance coverage for these procedures varies amongst insurers. It is important to check your individual policy and direct any questions to your insurer to determine coverage and your financial responsibility prior to receiving treatment.

Consults, office visits and telehealth have four to five coding levels that may be billed. The coding level applied to your service depends on the information obtained and documented during the appointment (including, but not limited to, the complexity of problems addressed, the amount and complexity of data reviewed/analyzed/ordered, and the level of risk of complications and/or morbidity/mortality of patient management.) Collectively these items determine the level of Medical Decision Making. Alternatively, consults, office visits and telehealth may be billed based on the total time of the visit on the date of service, including any pre- or post-visit work performed by the healthcare provider. Most consults and office visits by MNGI providers are billed at level three or four.

### **Consults**

A consultation is a type of service provided by a physician whose opinion or advice regarding evaluation and/or management of a specific problem is requested by another physician or other appropriate source.

#### New Patient Visits/Telehealth

New patient visits are billed to any new patient to MNGI or any established patient who has not been seen within the past three years who was not referred by another physician. Telehealth is an online video or telephone encounter with a secure medical discussion between a patient and a provider.

Clinic visits are billed to established patients of MNGI.
